APPLICATION FOR PERMISSION TO CONDUCT OPEN BURNING

I, _____, hereby make the above application for permission to conduct open burning and I do verify that the information set forth in this application is true and complete. If authorized, said open burning will occur only between the hours of 9:00 a.m. and 7:00 p.m. and only when prevailing winds are calm. The open burning will be attended throughout the burn and will burn no longer than three hours.

I hereby certify that materials will be dry and stacked (if appropriate) and otherwise prepared for burning in such a manner as to provide for the most complete combustion and least emission. It shall be no larger than 5 feet wide x 5 feet deep x 5 feet high.

I further certify that such open burning will not create a visibility hazard on public or private roadways, railroad tracks or air fields and that such burning will be performed at a point on the premises no less than 1000 feet from any structure in an unrestricted area.

I further acknowledge that certain materials will not be permitted for burning, such as aerosol cans; any plastic materials; all petroleum products, including roof shingles, tar and tires; and any hazardous material that may cause damage or harm to the natural environment.

I understand that Montville Fire Department, Montville Township and any employees of these entities are not liable for any damages or injuries as a result of this burn. The fire will be extinguished if found necessary by a fire or law enforcement official.

NOTE: Ohio EPA regulations overrule this burn permit. This permit is not valid on commercial property.
