### What's Happening in Your Township

I have never been one to wish-away a year, but I must admit, I am looking forward to the New Year and hope that 2021 brings better things to us all. We have all experienced a tumultuous 2020 that we will all certainly remember the rest of our lives.



The Township has received funds from the Coronavirus Aid, Relief and Economic Security Act (the CARES Act) in the amount of \$125,922.12. The Act outlines very specific spending requirements and covered costs. We have made the following purchases utilizing these funds:

 Replacement chairs that can be cleaned and sanitized for the Meeting Room, Social Room, Fire Department training room and offices and recliners

for the Fire Department dayroom.

- Laminate flooring for Fire Department training room, offices, Community Center hallway and stage in the great room.
- Touchless bathroom renovations including touchless toilet flushing, faucets, soap dispensers and paper towel dispensers.
- Cleaning supplies including a UV light and replacement bulbs, mounted hand sanitizer dispensers, backpack fogger and disinfecting supplies, detergent.
- Second set of personal protective equipment (PPE) for the Fire Department.
- Replacement of picnic tables and octagon tables at Community Center with poly tables that can be properly cleaned and disinfected.
  - Replacement doors for the Fire Department.

This means that we are providing the community the opportunity to purchase the tables and chairs we have replaced.

They are available to Montville residents or landowners only. You may purchase a quantity of 10 chairs and 1 table, and they are available on a first come, first serve basis. ## News From the Fire Department

#### New ambulance update

The new ambulance that is replacing our 2009 ambulance should be here sometime between January or February. It was delayed due to the coronavirus. More updates to come.

#### Recruitment and retention grant

We are pleased to announce that in September we were awarded the Staffing for Adequate Fire and Emergency Response (SAFER) Grant. This grant will allow us to recruit new members and retain current members for the Fire Department.

In 2021 we plan on doing an aggressive recruitment drive to bring new members to the department. Plans include social media, going to vocational schools on career day.

Also we will be getting a new LED sign in front of the community center to replace the old sign, this will allow us to advertise along with other information. This grant is funded for 2 years.

#### ► Open burn policies

This is a reminder that the Montville Fire Department requires a Burn permit. These permits are valid for 30 days. Permits can be obtained at the Fire Station. Depending on the situation an on-site inspection may be needed before a permit will be issued. The permit will be valid for yard waste only. Shingles, roofing material, or any non organic material will not be allowed.

If burning, any source of extinguishment is required close by IE: Fire Extinguisher or garden hose.

Ohio Revised Code 1503.18: Ohio DNR Forestry prohibits outdoor open burning and prescribed fires in the months of March, April, May, October, and November between 6am and 6pm. This ban includes burning of yard waste, trash, and debris, even in a proper

burn barrel.

Even outside the time and date restrictions, any person conducting a burn must obtain landowner permission, remain with the fire while it is burning, and take all reasonable precautions to prevent the fire from escaping.

Burn permits are available on the Montville Twp website, you can print the form at home and bring it to the Fire station for processing. The website is www.montvillegeauga.com.

Burn Permits are not valid for Commercial Property. Commercial property needs to get



a burn permit from the Lake County Health Department. Their website is https://www.lcghd.org/air-pollution-control/

#### ► Help us help you

The Montville Fire Department has address signs available for purchase; these signs are \$15.00 a piece and include numbers. By having your address posted at the road, this will help the fire department when trying to locate your residence in the event we need to respond for an emergency.

We are currently hiring part time fire fighter/EMT to staff the station We currently staff with 2 personnel Monday-Friday 8a-6p. With the cadet program, the cadets can respond with the Fire Department on emergency calls. The cadet program also gives a yearly stipend depending on how many calls the cadet responds to.

# From Fiscal Officer Karen Hawkins

I hope this finds everyone well and staying warm. I can't believe that preparations for 2021 are on their way. The Township is working on temporary budgets and looking at the organizational meeting items.

With the new challenges of COVID and all the requirements needed to be followed with the funding that was given to the Township, a challenge seems to be an understatement of the year.

2020 has been a busy year! The Township implemented a new account system. I have converted our financial records to the Uniform Account System (UAN) that is supported by the Auditor of State. Going from a manual system to the electronic system has taken some getting used to by all departments. Things are running smoothly and I have been able to

close the months easily.

Grants were applied for and awarded from:

- NOPEC Energy Grant was able to replace many lights with LED's in the road garage and fire station and a new commercial dishwasher in the kitchen.
- Geauga Trumbull Solid Waste District to help with the cost of tire collection at Clean-up day.
- Go Green, part of the Geauga Trumbull Solid Waste District, to help with the cost of trash removal on Clean-up day.
  - NOPEC Community Grant to help with the cost of trash removal on Cleanup day.
- Ohio Bureau of Workers Compensation grant helped purchase two power cots.
- Ohio Department of Public Safety to help send two firefighters to Paramedic school.
- The Department of Homeland Security SAFER Grant will help with retention & recruitment of firefighters.

### Townships Consider Joint Fire District

The Montville Township and Thompson Township trustees are considering the formation of a joint fire district to support the townships. The creation of a joint fire district is covered under Ohio Revised Code 505.371.

The purpose of a joint fire district is to provide better service and better coverage to the residents. There are many possible pros & cons including but not limited to: improved service, possible reduced equipment cost, standardized training and equipment, loss of individual township control, station location and operating costs.

The creation of a joint fire district would require a Fire District Board of Trustees which would include a trustee from each township as well as at least one resident from each township. Those four members may then jointly select the fifth member of the Board. The Fire District Board of Trustees will not include any member of the Fire Depart-

ment. Ideally, the Board will include individuals that can contribute to financial planning, marketing, strategy and recruitment and retention of staff for the joint fire district.

No voter approval is required to form a joint fire district; it is formed under a joint resolution between the boards of township trustees, however the trustees would like to obtain your feedback.
