### What's Happening in Your Township

With a wonderful summer wrapped up, Fall is upon us with the trees already in transition. I hope you all enjoyed the beautiful weather summer brought us and enjoyed the outdoors. Here is a recap of some of the township happenings:

With the support of Senator Sandra O'Brien, Montville Township is the recipient of \$1.25 million from the One Time Strategic Community Investment Fund. With these funds, we will be planning for an addition to the current fire department that will meet the future needs of the department and the community. A huge thank you to Senator O'Brien for her support of Montville Township.

The remaining American Rescue Plan Act funds were utilized to install a new swing set, mulch and border at the Community Center playground. The new swing set installed by Meyer Design includes four swings, a toddler swing as well as an inclusive support swing seat.

Vandalism has occurred at our Community Center playground and pavilion recently. Please be vigilant to ensure the property is respected and in good condition for the community for years to come. If you see something, say something. Call (440) 968-3784 and leave a message.

Work has begun at the township property located at 16867 GAR Hwy. This property was purchased by the township in 2003 with long term plans to develop for community use. The initial work in-progress is to create a parking lot at the property. Please note that the property is not currently open for accessibility by the public. We continue to monitor grant opportunities that will allow us to develop the property in the future.

The November ballot will include a 5-year renewal of a 2.4 mill Fire levy first voted on in 2000. This levy costs the homeowner of a single-family owner-occupied home \$37.00 for each \$100,000 of the County Auditor's appraised value and is for the purpose of providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery or other fire equipment and appliances.

Several road improvement projects are be-

ing worked on for 2025 and 2026. More information will be provided as soon as we have details to confirm as they do involve other townships.

Spring Clean Up Day is currently planned for Saturday, May 10, 2025.

Montville Community Day took place on September 14th. We had beautiful weather and the event has continued to grow with lots of booths, a fantastic performance by Thunder Creek Band, a demonstration by Geauga County Sheriff Randy Primer with K9 Justice, and Wiley West of Hidden Lakes Family Campground who entertained young and old alike with his mischief and mayhem.

### **Open Burn Policies**

This is a reminder that the Montville Fire Department requires a Burn permit. These permits are valid for 30 days. Permits can be obtained at the Fire Station. Depending on the situation an on-site inspection may be needed before a permit will be issued. The permit will be valid for yard waste only. Shingles, roofing material, or any non organic material will not be allowed. If burning, any source of extinguishment is required close by IE: Fire Extinguisher or garden hose.

Ohio Revised Code 1503.18 Ohio DNR
Forestry prohibits outdoor open burning and prescribed fires in the months of March,
April, May, October, and November This ban includes burning of yard waste, trash, and debris, even in a proper burn barrel.
Even outside the time and date restrictions, any person conducting a burn must obtain landowner permission, remain with the fire while it is burning, and take all reasonable precautions to prevent the fire from escaping.

Burn permits are available on the Montville Twp website, you can print the form at home and bring it to the Fire station for processing. The website is www.montvillegeauga.com

### BURN PERMITS ARE NOT VALID FOR COMMERCIAL PROPERTY

Commercial property needs to get a burn permit from the Lake County Health Department.

### **Cemetery News**

Currently, work is being done to complete a live fence on the North property line. Please, watch for workers and equipment. Please be considerate and keep your vehicles on the driveway when visiting. ### **Summer Lunch Program**

"Now That's What I'm Talking About!" Summer Lunch, a Claridon Community Helps program, served 14,099 lunches to children in Geauga County this past summer. This is a 9% increase from the number of lunches we served in 2023. This program is 100% volunteer driven. In total 139 volunteers gave 2,391 hours of their time and talent this summer. Of these 139 volunteers, 88 were adults and 51 were students. Total expenses for "Now That's What I'm Talking About!" - Summer Lunch program was \$31,437.32. This does not include Claridon Community Helps monthly insurance, telephone, website and garbage pickup during the summer. All expenses are paid from money received through donations and grants. It is not funded by the state or other agencies. It is solely funded by donations. The cost per lunch was \$2.23. The estimated cost per lunch was \$3.58 per child. Thanks to numerous donations we were able to deliver a homemade meal \$1.35 below our estimated cost per meal. I say this often, yet I cannot say it often enough, we live in an amazing community. People freely share their time and are not afraid to open their pocketbooks to purchase the items we need to make the summer lunch program happen. Claridon Community Helps was able to offer "Now That's What I'm Talking About!" because of you! Together, we are making a difference!
