#### OTHER:

Chief Jonovich explained an accident that occurred while fighting a fire. A sheriff vehicle was damaged by a fire vehicle, no damage was sustained to the fire vehicle. Blood Hound has been contacted to explore an area to locate underground storage tanks. BioSolutions has given a quote to perform all the needed tests on 1 well at a cost of \$1,235.00. Trustees discussed to set aside the cost for 2 sets of well tests; meanwhile, the USDA will be contacted to see if the 2 wells are needing tested; since, 1 is non-portable. Ms. Combs moved Mr. Peterson seconded to approve the testing of 2 wells, if needed. At a call for vote: Mr. Peterson AYE, Mr. Marsic AYE, Ms. Combs AYE. MOTION CARRIED.
